Registration for your **DAY** camper will take place at Stonehill College in the AMES SPORTS COMPLEX between 8:00am and 9:00am on August 2nd, 2010. The registration table will close promptly at 9:00am.

Please review the checklist in this email to ensure that you have all of the documents necessary to complete your registration. This checklist also includes some informative items that we strongly suggest reading prior to attending camp.

- c. PLEASE NOTE THAT THIS CAMP DOES NOT TAKE PLACE AT RBI BASEBALL ACADEMY IN FOXBORO.

2.) Medical Forms and other important documentation necessary to participate in ALL activities

- a. **Medical Information and Release**. This form is kept on file for the duration of the camp and holds critical information for the coaches, directors, and nurses. Please complete the attached form titled ***JVC Medical Information and Release.doc*** and return.
- b. **Physical Examination by Physician & Immunization Records**. Every camper prior to attending the Jason Varitek Baseball Camp must present the following, prepared and signed by a licensed health care provider. If these records are not on file prior to the first day of camp, the Massachusetts Board of Health along with RBI Baseball Academy will not allow your son to attend our camp. All records are kept confidential and are essential to ensure the safety and well being of each camper.  1. **Health History**
 2. **A report of a physical examination conducted during the preceding 12 months. All exams must be dated no earlier than August 1st, 2009**
 3. **An immunization history**
- c. **Authorization for Dispensing Medication**. This is the form you need to fill out if your camper needs to have prescription medication administered throughout the camp. Please complete the attached form titled ***JVC Authorization for Dispensing Medication.doc*** and return. This form will be stored with our camp nurse for the duration of camp.
- d. **Authorization for Over the Counter Medications/Aspirin Only**. This form allows the camp nurses station to administer over the counter medication to your camper in the event of a mild illness. Please complete the attached form titled ***JVC Over the Counter Form.doc*** and return.
- e. **Participant Release of Liability**. Please read the attached form titled ***JVC Participant Release of Liability.doc*** thoroughly before signing.

3.) Camper Authorization Forms

- a. **Early Release Forms** MUST be filled out for any camper that needs to leave early. Please note that ALL early release is done at 2:30pm each day. If your son/daughter is on the early release list for that day he will be supervised in the Ames Sports Complex beginning at 2:30. This also means he will not be participating in the afternoon baseball activities. Please see the attached form titled ***JVC Auth for Camper Early Release.doc*** to complete this form.
- b. **Authorization for Camper Release**. This form allows someone other than the camper's legal guardian to pick up your son or daughter from camp. We take the safety of each camper very seriously and want to ensure that each camper is returned home safely. If you have a camper's aunt, uncle, grandparent, babysitter, au pair, neighbor, car pooling group, or anybody else other than the camper's parents/legal guardian picking up your son/daughter, this form MUST be filled out or your son will not be able to leave camp until you are present. Please see the attached form titled ***JVC Authorization for Camper Release by NonGuardian.doc***

4.) Group/Rooming Requests

- a. **Grouping Requests**. Please complete the attached form if your son/daughter has a friend he/she would like to be grouped with. Our camps are divided by age groups. These groups are 7-8, 9-10, 11-12, 13, 14-16. Please note that we will do our best to accommodate these requests but campers should fall in the same age groups when being grouped together. This form MUST be filled out and returned to RBI by July 20th, 2010.
- b. **Please note that requests will not be taken over the phone or via email.** Please see the attached form titled ***JVC Roommate and Day Grouping Request form.doc*** for both of these forms.

5.) Camper Age Grouping

- a. The Jason Varitek Summer Baseball Camp groups all of its campers by age to ensure the highest level of satisfaction for its campers. The Jason Varitek Baseball Camp is divided by its director into 5 camps. Camps 1-3 are played on the standard Little League diamond, camps 4 and 5 are played on the standard Babe Ruth/High School diamond. If your son/daughter's Date of Birth is on or before April 30th, 1997 he/she will be playing in either Camps 4 or 5. If he/she was born on or after May 1st, 1997, they are considered of Little League age and will be playing on the Little League Diamond. If your son/daughter plays in a town where this is different and you would like him/her to be placed in a different age group, please email cwelch@rbiacademy.com to fulfill this request. This request must be made by July 20th, 2010. Our "sub-camps" are divided by the following ages.
 1. Camp 1 – 7+8 Year Olds
 2. Camp 2 – 9+10 Year Olds
 3. Camp 3 – 11 + 12 Year Olds
 4. Camp 4 – 13 Year Olds
 5. Camp 5 – 14 -16 year Olds

6.) What to Bring

7.) Camp Cancellation Policy

9.) Closing Ceremonies

- a. Friday August 6th is FAMILY DAY at the Jason Varitek Summer Baseball Camp. We strongly encourage all parents to come and join us for the duration of this day.
- b. Friday will consist of a review of the weeks on field instructional points as well as our CLOSING CEREMONIES
- c. Closing Ceremonies will begin at or around 11:00am and will conclude no later than 12:45pm.
- d. We suggest that all parents/guardians take part in our closing activities. Campers will received their packets from camp on this day.
- e. All campers **MUST** be picked up by 12:45pm on August 6th, 2010.

10.) Cell Phone Policy for day campers

- a. All cell phones are to be turned off during day camp hours (9am – 5pm). Prior to August 1st all parents will be given contact information so they may reach the staff at the Jason Varitek Summer Baseball Camp in the event of an emergency.
